Our History



Futta Deen Rane

Arrived in Australia in 1900

Futta Deen Rane was born in 1884, Punjab India. He studied Islam at Madressa Azizia in Bihar, India. Orphaned at a young age, he travelled to Australia alone at age 16.

He later married in Australia and worked tirelessly to raise his family and teach Islam to his 6 sons and 2 daughters. He passed away in 1958.

Abdul Rahim Rane

Imam of the first Mosque in Brisbane

Abdul Rahim Rane, son of Futta Deen Rane was born in 1916 in Brisbane, Australia. He married in Australia and raised 6 sons and 5 daughters. Imam Rane served the community as an unpaid Imam at the Holland Park Mosque for more than 30 years. He was the longest serving and only Australian born Imam in Queensland.

Imam Rane was a pillar of the community and a beacon of Islam in Queensland at a time when there were no other sources of Islamic leadership. Imam Rane was known and beloved to the Queensland and Australian Muslim community and continued serving and guiding the community until he passed away in 2006.

Yousef Ali Rane Founder of Al-Mustapha Institute

Yousef Ali Rane, son of Abdul Rahim Rane was born in 1950 in Brisbane, Australia. He is married, with 1 son and 2 daughters. In 2001, to promote Islamic education and spread Islam in the growing community, Haji Yousef and his family established Al-Mustapha Institute of Brisbane.

The family legacy established more than 120 years ago of working for Islam unpaid with the sole purpose of serving Allah will carry on at Al-Mustapha Institute through Haji Yousef, his children and grandsons.



Al-Mustapha Timeline

2001



Al-Mustapha Institute of Brisbane was first established and registered.

2012



Registered as a not-for-profit organisation with the Australian Charities and Not-for-Profits Commission (ACNC).

Recognised as a registered training organisation providing certified Islamic education courses.

2022



10 Estramina Road, Regents Park was purchased. Building to be demolished prior to construction.

2009



Purchased 39 Bushmills Court, Hillcrest and established the first Islamic Centre in this area providing Islamic education and services to the local community.

2016



The need to expand current services to a larger site was identified as major growth in the community occurred.


The search began for a property that seamlessly aligned with community needs and local government planning regulations.






Site Location







